

**THE CORPORATION OF THE TOWNSHIP OF TAY**

**BY-LAW NO. 2011-89**

**Being a by-law to re-divide the  
Wards in the Township of Tay**

**WHEREAS** a petition was received in accordance with Section 223 of the Municipal Act, 2001, as amended, requesting that the Council divide or redivide the municipality into wards;

**AND WHEREAS** the Council of the Corporation of the Township of Tay is authorized by Section 222. (1) to divide or re-divide the municipality into wards or to dissolve existing wards;

**AND WHEREAS** Council is desirous of re-dividing the wards for a more equitable population distribution amongst the wards; and

**AND WHEREAS** Council at its meeting of December 14, 2011 by Council Resolution approved new ward boundaries.

**NOW THEREFORE the Council of The Corporation of the Township of Tay enacts as follows:**


1. The Township of Tay shall be re-divided into three wards, as designated by the numbers as described in Schedule 'A' attached hereto and as depicted on the map in Schedule 'B' attached hereto.
2. That there shall be two councillors elected in each of Wards 1 and 2 and one councillor elected in Ward 3.
3. That this by-law comes into force on the day set out in Subsection 222(8) of the Municipal Act, S.O. 2001, c.25, as amended.

## **Schedule 'A' to By-law 2011-89**

### **Ward 1**

Commencing at the point where the boundary of the Township of Tay, the Township of Tiny and the Town of Midland coincide;

Thence southerly along the westerly boundary of the Township of Tay to a point where the boundary of the Township of Tay, the Township of Tiny and the Township of Springwater coincide;

Thence following the southerly boundary of the Township of Tay to a point being the southeast corner of Lot 1, Concession 3, Township of Tay;

Thence northerly along the easterly limit of Lots 1 through 10, Concession 3, Township of Tay to the southeast corner of Lot 11, Concession 3, Township of Tay;

Thence easterly along the southerly limit of Lot 11, Concession 4 and 5 to a point being the south east corner of the west half of Lot 11, Concession 5, Township of Tay;

Thence northerly along the line dividing the East and West halves of Lots 11 through Part of Lot 13, Concession 5, Township of Tay to the intersection with the shoreline of Hogg Bay of Severn Sound;

Thence northerly and westerly along the shoreline of Severn Sound to the northwest corner of Lot 19, Concession 3, Township of Tay, at the mid-point in the Wye River, being the boundary between the Township of Tay and Town of Midland;

Thence westerly and along the northerly boundary of the Township of Tay to the point of commencement.

This Ward also includes the water lots at Lots 19 and 20, Concession 3, Lot 15, Concession 5 and Lots 15 to 18, Concession 6, Township of Tay.

### **Ward 2**

Commencing at the southwest corner of Lot 1, Concession 4, Township of Tay;

Thence northerly along the westerly limit of Lots 1 through 10, Concession 4, Township of Tay to the northwest corner of Lot 10, Concession 4, Township of Tay;

Thence easterly along the northerly limit of Lot 10, Concession 4 and 5 to a point being the south east corner of the west half of Lot 10, Concession 5, Township of Tay;

Thence northerly along the line dividing the East and West halves of Lots 11 through Part of lot 13, Concession 5, Township of Tay to the intersection with the shoreline of Hogg Bay of Severn Sound;

Thence easterly and southerly along the shoreline of Severn Sound to the intersection with the southerly limit of Lot 10, Concession 8, Township of Tay;

Thence westerly along the southerly limit of Lot 10, Concession 8, Township of Tay to the southwest corner of Lot 10, Concession 8, Township of Tay;

Thence southerly along the westerly limit of Lots 9 through 1, Concession 8, Township of Tay to the southwest corner of Lot 1, Concession 8, Township of Tay;

Thence westerly along the most southerly limit of the Township of Tay to the point of commencement.

This Ward also includes the water lots at Lots 14 and 15, Concession 7, Township of Tay and Methodist Island.

### **Ward 3**

Commencing at the southwest corner of Lot 1, Concession 8, Township of Tay;

Thence easterly along the most southerly limit of the Township of Tay to the most southeast corner of the Township of Tay being a point in the boundary of the Township of Tay and the Township of Severn;

Thence northerly along the boundary of the Township of Tay and the Township of Severn to the intersection with the shoreline of Severn Sound at Lot 18, Concession 12, Township of Tay;

Thence southwesterly along the shoreline of Severn Sound along Lots 18, 17, 16, 15 and 14, Concession 12, Township of Tay and Lots 13, 12, 11 and 10, Concession 11, Township of Tay, including the entire shoreline of Waubauskene, as well as the shoreline of Lot 10 and 9, Concession 9, Township of Tay and Lots 10 and 9, Concession 8, Township of Tay to a point where the shoreline intersects with the southerly limit of Lot 10, Concession 8, Township of Tay;

Thence westerly along the southerly limit of Lot 10, Concession 8, Township of Tay to the southwest corner of Lot 10, Concession 8, Township of Tay;

Thence southerly along the westerly limit of Lots 9 through 1, Concession 8, Township of Tay to the point of commencement.

This Ward also includes all water lots (excepting the water lots at Lots 19 and 20, Concession 3, Lot 15, Concession 5, Lots 15 to 18, Concession 6 and Lots 14 and 15, Concession 7, Township of Tay) and all Islands (excepting Methodist Island) within the municipal boundary of the Township of Tay.
